Jane Ambachtsheer is Expert Member in the TCFD and Partner and Chair of Mercer's Global Responsible Investment Business. She is responsible for overseeing the group's strategy, developing intellectual capital across a range of responsible investment topics, and advising investors in Europe and North America. Jane was consultant to the UN through the development of the Principles for Responsible Investment (PRI). She is a Trustee of CDP and a member of the Academic Working Group of the PRI. Jane is the author or co-author on a number of industry-leading papers and reports.



Julian Beer is the Head of ESG Financial Advisory at SEB. During his 20 years with SEB, Julian has been a top ranked equity analyst in the Oil, Oil Services, Metals and Mining, and Capital Goods sectors. In 2014, he assumed responsibility for developing methodology to integrate non-financial parameters into SEB Equities' standard financial valuation process. This methodology is now known as the "SAFE" approach, or "SEB's Adjustment for ESG". A key element of SAFE has been an unerring focus on value impact, rather than using the currently popular qualitative system of ESG assessment.



Daniel Brooksbank is the Editor of Responsible Investor. He has been News Editor at Investment & Pensions Europe (IPE) from 2002 to 2007. Formerly he has been Multimedia Editor, Europe for Bloomberg News and Economics Editor at IDEAglobal.com. He has also been the moderator of the European Parliamentary Pension Forum and has appeared on CNBC and the BBC. He has started his career at Reuters, initially in investor communications before moving on to edit its online staff newsletter.



Dr Maximilian Horster is Managing Director of ISS-Ethix Climate Solutions, previously the investment climate data division of South Pole Group. In this capacity, he pioneered in 2010 the leading methodology to establish climate impact assessments of investment portfolios. Max also leads two EU Climate-KIC funded GHG financial accounting projects, is working in several industry organisations dealing with GHG accounting and frequently publishes on investments and climate change.



Jukka Honkaniemi is a Senior Banker and Head of Sustainability for LC&FI Division at SEB. During his 27 years in banking Jukka has advised companies on wide variety of financial issues around strategic and transformational situations and held various managerial responsibilities at local and global levels. Prior to SEB he worked at Citigroup in Helsinki and London for 15 years.
